NOTIFICATION: RECRUITMENT THROUGH UNIT HEADQUARTER QUOTA (UHQ) AT 1 EME CENTRE, BOLARUM (SECUNDERABAD), FOR AGNIVEER (AGNIPATH SCHEME) FOR WARDS OF WAR WIDOWS / WIDOWS/EX-SERVICEMEN/ SERVICEMEN AND OWN BROTHER OF SERVICEMEN/ EX-SERVICEMEN FOR THE RECRUITING YEAR 2025-26

Special Instructions

- 1. Recruitment rally under Unit HQ Quota (UHQ) is being scheduled to be held at this Centre wef 01 Aug 2025 onwards for Son of War Widow/Widow/Ex-servicemen/Servicemen and own Brother of Servicemen/Ex-servicemen for Agniveer GD, Agniveer Technical, Agniveer (Tdn) Category 10th Edn Std Cat (Chef) and Open Category for Outstanding Sportsmen i.e Swimming & Diving and Volley ball only. Eligible candidates are required to report at Milkha Singh Stadium, 1 Training Battalion, 1 EME Centre, Secunderabad at 0600h on 01 Aug 2025 for preliminary screening with all documents.
- The enrolment will be carried out as per Recruitment Directive for Recruitment of JCOs/OR 2014 & AREP-2017 issued by IHQ of MoD (Army) and amount thereto. Tentative sequence of recruitment rally being conducted from 01 Aug 2025 onwards will be as under:-
 - (a) Pre-height and Pre-documents check.
 - (b) Conduct of Sports trials of potential sports players (Volleyball & Swimming).
 - (c) Physical Fitness Test (PFT), (Run, Beam, Ditch & Zig-Zag Balance).
 - (d) Physical Measurement Test (PMT) (Height, Weight & Chest).
 - (e) Adaptability test (Psychometric) as per new policy on the day.
 - (f) Detailed Document check and Prep of Recruits Master Data Sheet (RMDS).
 - (g) Primary Medical Examination and Review Cases.
 - (h) Preparation and issue of Admit Card.
 - (j) Conduct of Common Entrance Examination (CEE).

Note:- All candidates after qualifying the PFT & PMT will have to undertake Adaptability test as per new policy on the day. Adaptability test is for selection of candidates who can adapt to the environment of the Indian Army and are able to adapt to the challenges of military life. Those candidates who will qualify the above test will be eligible for medical & further recruitment process.

 Terms & Conditions. The salient aspects of terms and conditions of service for Agniveers enrolled through the Agnipath Scheme for service in the IA are mentioned in the succeeding paragraphs.

(a) Enrolment.

- (i) Candidates will be enrolled under Army Act 1950 for a service duration of four (04) years including the training period.
- (ii) Agniveers so enrolled will be subject to Army Act, 1950 and will be liable to go wherever ordered, by land, sea or air.
- (iii) Agniveers enrolled under the scheme, will not be eligible for any kind of Pension or Gratuity.



(iv) All aspect of terms and conditions of service for persons enrolled through the Agnipath Scheme for service in the IA are available on home page of www.joinindianarmy.nic.in.

(b) Service.

- (i) Service of Agniveers will commence from the date of commencement of training.
- (ii) Agniveers would form a distinct rank in the IA, different from any other existing ranks.
- (iii) Leave, Uniform, Pay & Allowances during the service period of four years will be governed by orders and instructions in respect of such individuals issued by the Government of India (GoI) from time to time.
- (iv) Agniveers will be liable to be assigned any duty in organizational interest, as decided from time to time.
- (v) Personnel enrolled though Agniveer Scheme, will be required to undergo periodical medical check-ups and physicals/written/field tests as governed by orders issued. The performance so demonstrated would be considered for subsequent offer for enrolment in the Regular Cadre.
- (vi) Agniveers can be posted to any regiment/unit and can be further transferred in organizational interest.

(c) Discharge.

- (i) All Agniveers will be discharged on completion of four years of service.
- (ii) On discharge after completion of four years, Agniveers will be paid a 'Seva Nidhi' package to enable them to return to the society for pursuing employment in the other sectors.
- (iii) After discharge Agniveers will not be eligible for any kind of pension or gratuity, neither will they be eligible for Ex Servicemen Contributory Health Scheme (ECHS), Canteen Stores Department (CSD) facilities, Ex Servicemen status and other related benefits.
- (iv) Agniveers will be barred from disclosing classified information gained during service to any unauthorized person or source under Official Secrets Act, 1923.

(d) Enrolment for Regular Cadre.



- (i) Based on organizational requirements and policies promulgated. Agniveers who are completing their engagement period in each batch will be offered an opportunity to apply for enrolment in the regular cadre of IA. These applications will be considered in a centralized manner by the army based on an objective criteria including performance during their engagement period and not more than 25% of each specific batch of Agniveers will be enrolled in regular cadre of the IA, post completion of their four years engagement period.
- (ii) Agniveers so enrolled as regular cadre would be required to serve for a further engagement period of 15 years and will be governed by terms and conditions of service (of Junior Commissioned Officer/Other Ranks in IA) currently in vogue (as amended from time to time). Agniveers will not have any right to be selected. Selection will be exclusive jurisdiction of the IA.
- (iii) With introduction of this Scheme, the enrolment of soldiers in the regular cadre of IA, except technical cadres of Medical Branch, will be available only to those personnel who have completed their engagement period as Agniveer.

Employability.

- (a) Agniveers will be liable to be assigned any duty in organizational interest, as decided from time to time.
- (b) Agniveers can be posted to any regiment/ unit and can be further transferred to other regiments/units in organisational interest.
- 5. <u>Leave</u>. Grant of leave will be subject to exigencies of service. The following leave may be applicable for Agniveers during their engagement period: -
 - (a) Annual Leave. Upto 30 days per year.
 - (b) Sick Leave. Based on medical advice.

Pay, Allowances & Allied Benefits.

(a) Agniveer Package.

- (i) The pay & emoluments of Agniveers will be as given below: -
 - (aa) Year-1. Customised Package Rs 30,000/- (Plus applicable allowances)
 - (ab) Year-2. Customised Package Rs 33,000/- (Plus applicable allowances)
 - (ac) Year-3. Customised Package Rs 36,500/- (Plus applicable allowances)
 - (ad) Year-4. Customised Package Rs 40,000/- (Plus applicable allowances)
- (ii) From the above packages, 30% will be compulsorily deposited every month in a corpus which will be matched by the Government of India (GoI). Balance amount less the corpus contribution will be the in-hand component.
- (b) <u>Seva Nidhi Package</u>. On discharge at 4 years, the corpus of Rs 5.02 lakhs will be matched by Government of India, an amount of Rs 10.04 lakhs and accrued interest will be given to the Agniveers. In case of Agniveers who are subsequently selected for enrolment in IA as regular cadre, the "Seva Nidhi" package to be paid to them will comprise only their contribution including accrued interest thereon. In the case of Agniveers existing service before the end of their engagement period on their own request, the individuals Seva Nidhi package, accumulated as on date, will be paid with the applicable rate of interest. In such cases, no Govt contribution to Seva Nidhi Package will be entitled. The "Seva Nidhi" will be exempt from Income Tax.
- (c) <u>Payment Modality-Seva Nidhi Package</u>. Two options to receive Seva Nidhi package will be provided to each Agniveers, with an aim to provide financial loans from self employment /entrepreneurship through a bank Guarantees also to meet immediately /incidental expenses, on exit. Firm details will be promulgated separately.
- (d) <u>Allowances</u>. The Agniveer pay is a composite package and he will not be eligible for any Dearness Allowance and Military Service Pay. He will get applicable Risk & Hardship, Ration, Dress and Travel allowances as decided by the Government of India from time to time.
- (e) Agniveers will be exempted from making any contribution in Armed Forces Personnel Provident Fund or any other Provident Fund.
- (f) There shall be no entitlement towards gratuity or pensionary benefits for Agniveers enrolled through this scheme.
- Life Insurance Cover. Agniveer will be provided non-contributory life insurance cover
 of Rs 48 lakhs for the duration of their engagement period and they will not be eligible for Army
 Group Insurance Fund (AGIF) schemes /benefits.



8. Termination/Release from Service.

- (a) The maximum period of service for Agniveers will be as enumerated at Para 2 above. However, the services of Agniveers under this scheme may be terminated at any time in accordance with the Army Act 1950.
- (b) Release at own request prior to completion of terms of engagement of Agniveers is not permitted. However, in most exceptional cases, personnel enrolled under this scheme may be released, if sanctioned by competent authority.
- 9. <u>Benefits for Personnel Exiting at Four Years of Service</u>. After completing four years of service (as applicable) the following benefits will be offered to the exiting individuals:-
 - (a) <u>Seva Nidhi Package</u>. Refer para 5 (a) above. The corpus generated after four years of contribution will be paid to the exiting Agniveers.
 - (b) Agniveer Skill Certificate. At the end of engagement period, a detailed skill set certificate will be provided to the Agniveers, highlighting the skills and level of competency acquired by the personnel during their engagement period.
 - (c) <u>Class 12th Certificate</u>. Agniveers who have been enrolled after qualifying Class 10th, a certificate for 12th (equivalent) will be given on completion of their 4 years engagement period, based on skills attained.
- 10. Unit Headquarter Quota (UHQ) recruitment rally under Agnipath Scheme for wards of Servicemen/Ex-servicemen/Widow(s)/War Widow(s) and one real Brother of Servicemen/Ex-Servicemen will be conducted at this Centre from **01 Aug 2025** onwards.
- 11. The cutoff date for calculation age would be **01 Oct 2025**. The age limit of candidates for various categories are as under :-

13. Relationship Criteria. Unit Headquarter Quota (UHQ) recruitment is applicable for only One son/One real brother of servicemen/Ex-servicemen. Original Relationship certificate issued by concerned Records Office with watermark of issuing Record Office is mandatory for enrolment under Unit Headquarters Quota (UHQ). Bonus marks is applicable only for one son of servicemen/Ex-servicemen only. If the Relationship certificate has also been issued to brother /brothers of the candidate and not utilized, then the candidate shall bring the ORIGINAL INK SIGNED copy of the relationship certificate issued to his brother/ brothers. Relaxation in physical standards to wards of Servicemen/ Ex-Servicemen are done away from recruiting year 2024-2025 (i.e from 01 Apr 2024 onwards).

- 14. <u>Instant Enrolment for Wards of Battle Casualty</u>. The wards of battle casualty will be provided instant enrolment as per laid down guidelines of Recruitment Directive for recruitment of JCOs/OR -2014. The following conditions for instant enrolment are as under:-
 - (a) This implies the real Son/ legally adopted Son of Army Personnel. In case the son is born after the death of Army person and Part II order was not published, the widow should submit an Affidavit from Class I Judicial Magistrate and a cert from the Local Zila Sainik Board duly authenticating the birth of the son.
 - (b) One son of the Battle Casualty invalided out of service on medical ground shall be given instant enrolment without putting him through Physical Fitness Test (PFT) and Written Test provided the son/brother, meets the minimum laid down edn, age, physical and medical criteria except for Agniveer Technical category. Technical category candidate shall have to acquire minimum prescribed pass marks and they will then be recruited without placing them in the merit list. In case the ward of the battle casualty is under age, he will be enrolled as and when he attains the age required for enrolment.
 - (c) One real brother of Battle Casualty as per service document (If the deceased soldier/battle casualty was unmarried/issueless or had no male child) who died in war or war like situation during peace time (like CI Ops or while providing aid to civil auth).
- 15. Recruitment under Unit HQ Quota is purely based on priority as enumerated below:-

(a) <u>Priority 1 : (Own Regt/Corps) (Battle Casualty/ Liberalised Family Pension) – (EME ONLY)</u>.

- One Son of War Widow in receipt of Liberalised Family Pension to include legally adopted son.
- (ii) Real Brother of Battle Casualty who marries the Widow of Battle Casualty.
- (iii) One son-in-law of Battle Casualty having no son to include husband of legally adopted daughter.
- (iv) One real brother of unmarried battle casualty.

(b) Priority 2 : (Own Regt/Corps) (Disability Pensioners / Special Family Pensioners) - (EME ONLY).

- (i) In respect of Servicemen who die in harness, one son/one legally adopted son or one real brother if the Serviceman is unmarried where the widow /NOK is in receipt of Special Family Pension.
- (ii) One son /one legally adopted son of Ex-serviceman or one real brother if the Ex-serviceman is unmarried) in receipt of Disability Pension of 20% or more as revised wef Feb 2018 and the disability is attributed to/aggravated by Military Service.

(c) Priority 3 : (Own Regt/Corps) (Serving / Ex-serviceman) – (EME ONLY).

- THE CENTER OF THE PARTY OF THE
- (i) One son to include legally adopted son of serviceman who die in harness and not attributable to military service.
- (ii) One son of Serving/Ex-serviceman to include legally adopted son.
- (iii) One brother of service / Ex-serviceman.

(d) <u>Priority 4 : (Other Regt/Corps) (Battle Casualty/ Liberalised Family Pension)</u> - (NON EME).

- (i) One son of war widow in receipt of Liberalised Family Pension to include legally adopted son.
- (ii) Real brother of battle casualty who marries the widow of battle casualty.
- (iii) One son-in-law of battle casualty having no son to include husband of legally adopted daughter.
- (iv) One real brother of unmarried battle casualty.
- (e) Priority 5 : (Other Regt/ Corps) (Disability Pensioners/ Special Family Pensioners) (NON EME).

(i) In respect of serviceman who die in harness, one son / one legally adopted son or one real brother if the serviceman is unmarried where the widow / NOK is in receipt of Special Family Pension.

(ii) One son / legally adopted son of Ex-serviceman or one real brother (If the ex-serviceman is unmarried) in receipt of Disability Pension more than 20% and

the disability is attributed / aggravated by Military Service).

(iii) One son to include legally adopted son of serviceman who die in harness and not attributable to military service.

(iv) One son of serving / Ex-serviceman to include legally adopted son.

(v) One brother of service / Ex-serviceman.

(vi) Wards of TA pers.

- 16. Present Qualitative Requirement (QR) in terms of physical standards, relaxation in physical standards (Outstanding Sportsmen only), education standards, physical fitness test and bonus marks in CEE for UHQ enrolment are attached at **Appendix 'A'**.
- 17. Candidates to report to this Centre as per schedule given at Para 1 (Milkha Singh Stadium, 1 Training Battalion, 1 Training Battalion, 1 EME Centre, Secunderabad) alongwith documents and certificates mentioned in succeeding paragraphs, in original alongwith two additional photocopies duly self attested for registration /documentation formalities.
- 18. Relationship Certificate. SOS/ SOEX/ SOW/ SOWW/ BOS/ BOEX candidates are required to produce the following documents:-
 - (a) Relationship certificate issued form respective Records Office only duly signed by Record Officer with personal number, rank, name and particulars of the Record Officer issuing the Relationship certificate with office seal/stamp is endorsed. Relationship certificate should bear watermarks of concern Record Office.
 - (b) Original Discharge Book of Ex-servicemen also to be produced. Name and date of birth of the candidate must have been recorded in it.

19. Relationship Cert : DSC Personnel.

- (a) DSC personnel who are Ex-servicemen from Regular Army. Relationship certificate will be issued by the parent Records Office.
- (b) <u>Serving/ Pensioners DSC persons who are not Ex-Servicemen from Regular Army</u>. Relationship certificates to be issued by DSC Records and DSC will be mentioned as Regiment/ Corps.
- (c) <u>Territorial Army Persons Serving in SC or retired with pension from DSC.</u>
 Same as para 19 (b) above.
- (d) Territorial Army Ex Servicmen who have not earned pension from DSC or not re-enrolled in DSC. Territorial Army serving and Territorial Army Ex-servicemen will get relationship certificate from their affiliated Record Office of Regular Army.

Educational Certificate (Mandatory).

- (a) All educational qualifications achieved by candidate's i.e SSLC/ Matric/10th /10+2/Intermediate/Higher Secondary Certificate/ College/University (Mark Sheet & Education Certificate in original alongwith two self-attested copies of mark sheets and board certificate).
- (b) Provisional /online education/ITI & Diploma certificates should be certified ink signed by the head of the educational institution of concerned Board/University.
- (c) Candidate with matric certificate from Open School should bring School Leaving Certificate countersigned by Block Education Officer/Distance Education Officer.
- (d) List of Education Board recognized by State Government/ UT administrations is attached as **Appendix 'B'** will only be accepted.

- 21. <u>Nativity/ Permanent Residence (Mool Niwas) Certificate</u>. Nativity/ Permanent residence certificate with current photo of the candidate affixed and duly attested and signed by State authorities empowered to issue such certificates. Full name and designation of the Officer, issuing the certificate must be recorded legibly.
- 22. Affidavit. The candidates submit an affidavit at the rally site to include details of previous recruitment rallies he has attended and duly signed by candidate on Rs 10/- non judicial stamp paper as per specimen duly attested by notary will be submitted by the candidate at the rally site without fail. Format affidavit attached as per Appendix 'C'. Submission of affidavit is mandatory.
- 23. <u>Caste (Jaati Praman Patra) Certificate</u>. With photo of the candidate affixed and duly attested and signed by the stste authority empowered to issue the certificate (SDM/TEHSILDAR/SDO) with his stamp. Full name, designation and signature of the officer issuing the certificate and office round stamp must be legible. For General category candidates a certificate to this effect duly signed by Village Sarpanch/ Pradhan/ Ward member is required on his letter pad.
- 24. Religion Certificate. Religion certificate to be issued by the Tehsildar/SDM (if religion is "SIKH/ HINDU/ MUSLIM/ CHRISTIAN" is not mentioned in caste certificate).
- School Character Certificate. School Character certificate issued by the School/College Principal/Headmaster where the candidate last studied.
- 26. <u>Discharge Book</u>. In case candidate is son/brother of Ex-servicemen, he shall produce discharge book in original duly highlighted complete details of family members including himself. In case the candidate fails to produce **original discharge book** at the rally site, he may **not repeat not be allowed to participate** in the rally.
- 27. Pension Book/ PPO. In case sponsor is a widow of battle casualties or in receipt of special family pension/ liberalized family pension/ is in receipt of disability pension more than 20% and disability is attributable/ aggravated by military service. The candidate shall bring pension book/ PPO in original. In case the candidate fails to produce original pension book at the rally site, he may not repeat not be allowed to participate in the rally.
- Police Verification certificate. With current photographs duly attested and issued by SP office. Validity of the same is six months from the date of issue.
- 29. <u>Unmarried Certificate</u>. Unmarried certificate for all candidates, with photographs issued by Village Sarpanch/ Municipal Corporation with last six months (Performa is as per **Appendix 'D'** attached) (Agniveer must undertake not to marry during the defined period of engagement of four years. Agniveer who marry during the said period would be released from service. Further, only unmarried Agniveers will be eligible for enrolment in regular cadre as Sepoy/ equivalent on selection as currently in vogue).
- 30. <u>Aadhar/ UID Card, PAN Card, Bank Details, E-mail ID and Mobile Number.</u> Candidates will submit 02 x self-attested copies of Aadhar Card, Pan Card, Bank details (duly signed by branch manager), E-mail ID and mobile number.
- 31. <u>Photographs</u>. Twenty (20) copies of unattested passport size colour photographs developed in good quality photographic in **white background** not more than three months old. **Computerized /photocopied/shopped photograph will not be accepted**. Photographs must be with proper haircut and clean shave (**except SIKH candidate**).
- 32. NCC Certificate. NCC A/ B/ C certificate and Republic Day Parade certificate should have photograph of the candidate duly attested by issuing authority i.e Commanding Officer/Officer Commanding NCC Battalion/ NCC Group Commander/ Additional Director General of NCC Directorate. Provisional NCC A/ B/ C pass certificate will only be accepted if authenticated by concerned NCC Group Commander as applicable. These provisional certificate will be accepted only for participating in the Unit Headquarter Quota Recruitment Rally till medical. Candidates will have to produce original certificates which will be sent for verification by issuing authority. No bonus marks will be allotted unless the certificates (Relationship/ Sports/ NCC/ITI) have been verified. An undertaken to the effect will be obtained from the candidate (As per the Performa att as Appendix 'N'). Candidates will be allowed to appear in UHQ Rect Rally on basis of Provisional certificate. However, he will have to provide original certificates in the given time frame to appear in CEE.

- 33. <u>ITI/ NTC Certificate</u>. ITI/ NTC (National Trade Certificate) certificate from institutes which are set up under Directorate General of Training (DGT), Ministry of Skill Development & Entrepreneurship (MOSDE), and Government of India will be considered for bonus marks after verification. These training institutes are Government run training organizations and private Industrial Training Centres. These institutes are affiliated to National Council for Vocational Training (NCVT) and run by program under Craftsman Training Scheme.
- 34. <u>Consent Certificate</u>. Candidate below **18 yrs of age** should bring 'Consent Certificate' from their parents stating that they are willing for enrolment of their son in the Army and will not claim for compensation for any injury caused during screening (Performa is as per Appendix 'C' attached).
- 35. Character/ Pre-verification Certificate. Family photo of all members with name, relation and present occupation below the photographs. The certificate should be attested and also verified by the village Sarpanch/ Pradhan/ Ward Member with his stamp affixed on the both side character/ verification certificate. Serving Father/ Brother of the candidate in the photograph will be in uniform. Mixing/ patching/Edited photographs will not be accepted. Validity the same is six months from the date of issue (Performa is as per Appendix 'E' attached).
- 36. <u>Serving Certificate</u>. Serving certificate of sponsor with photograph (of serving soldier) dully attested, and countersigned by OC/CO Unit, if father/ brother of the candidate is a serving soldier (Performa is as per **Appendix 'F'** attached).
- 37. As per present policy, a servicemen/ ex-servicemen can avail sponsorship facility for one real son /brother only. Hence, as affidavit by the sponsorship individual to this effect that he has not availed sponsorship facility earlier throughout his life for his one real son/one real brother (as applicable) will be submitted. The affidavit will be made on Rs 10/- non judicial stamp paper in English with photograph duly attested. It will be signed by Executive Magistrate CI-I /SDM /Tehsildar /Notary duly affixing his name bearing rubber stamp and office stamp (Performa is as per **Appendix 'G'** attached).
- 38. As per present policy only genuine and eligible candidates can apply for enrolment in Army being wards and brother of servicemen/ex-servicemen. In addition, an affidavit will be made on Rs 10/- non judicial stamp paper in English with photograph duly attested. It will be signed by Executive Magistrate CI-I /SDM/Tehsildar/ Notary duly affixed his name bearing rubber stamp and office stamp (Performa is as per **Appendix 'H'** attached).
- 39. <u>Body Tattoos</u>. The candidates sporting permanent body tattoos on the following body parts are eligible for enrolment:-
 - (a) Tattoos on inner face of forearms (from inside of elbow to the wrist).
 - (b) Tattoos on back (dorsal) part of hand /reverse side of palm.
 - (c) Tribal's with tattoo marks on the face or body as per their existing custom and traditions of their tribes will be dealt on a case to case basis.
- 40. Any candidate with a permanent body tattoo on any other part of the body other than that specified in Para 37 (a) to (c) above is **NOT** eligible for enrolment. Such candidate will be rejected by the screening team, as soon as the non-permissible tattoo is noticed at any stage of the recruiting procedure. All candidates having any permanent body tattoos will produce an undertaken certificate duly signed by the candidate at the time of screening as per **Appendix 'J'** attached. Certificate of belonging to a tribal community and permissibility of permanent body tattoo(s) as per format at **Appendix 'K'** to be signed by District Magistrate/SDM/ Tehsildar/ Notary/ Signature with Name, Designation if any and address of Chairman/Secretary or senior Member of the Tribe to which the Candidate belongs to with their stamp where the tribe of the candidate is presently settled (Name and designation of the concerned official must be clearly mentioned).
- 41. Personal details, Nativity and Caste/ Sub Caste. Personal details (i.e name of father, mother, candidate & date of birth) will be filled up as per Class 10th (Matriculation Certificate). Details of home address as per nativity (Mool Niwas) and caste/ sub caste as per caste certificate of candidate should be endorsed on all documents and affidavit (except serving certificate of sponsor).

- 42. Variation in the Candidate's Name/ Father's Name & Mother's Name. The particulars of name of the father, name of the mother and date of birth listed in 10th Class certificate will be taken as final for the purpose of enrolment. In case of individual's name, father's name/ mother's name, surname (spelling variation may be accepted as long as the name remains the same. Similarly, when the surname has been included in the certificate but not included in the other, it may also be accepted as long as the name is same. In no case, an entirely different name in one of the certificate be accepted as shown on the 10th class vis-à-vis relationship certificate will need to be established. Affidavit on a Rs 10/- non judicial stamp paper duly countersigned by the Executive Magistrate /Class-I /Notary is required (Performa is as per Appendix 'L' attached) with name bearing rubber stamp and office round stamp. The affidavit will be submitted by the father of the individual or mother in case of widow.
- 43. <u>Variation in Date of Birth</u>. A variation upto 366 days in the date of birth recorded in the official records and the education certificate (10th Class/Matric) of the candidates will be taken as a minimum or variation and considered for enrolment. Any variation beyond 366 days will be treated as major variation and such candidate will not be considered for UHQ enrolment. Affidavit on Rs 10/- non judicial stamp paper duly countersigned by the Executive Magistrate Class-I/ Notary is required (as per Appendix 'L') with name bearing rubber stamp and office round stamp.
- 44. Ambiguity in Date of Birth Mentioned in Relationship Certificate. Ambiguity in date of birth mentioned in relationship certificate (for example Date of Birth mentioned as 'Candidate was 08 years at the time of enrolment of his brother' etc) will not be accepted. Date of birth of candidate should be mentioned clearly in figures (i.e DD.MM.YYYY) format in Relationship Certificate). Correct mentioning of date of birth in Relationship Certificate of son/brother of servicemen & son/brother of Ex-servicemen is an inescapable and mandatory requirement for enrolment in the Army. Candidates shall be entertained at recruitment rally site only on producing correct Relationship Certificate (duly highlighting the correct Date of Birth in figures).
- 45. Variation in Residential Address Between Nativity Certificate and Relationship Certificate. Nativity/ domicile/ mool niwas certificate is the primary document for residential address. All subsequent address verifications will be based on this certificate and address mentioned in caste certificate, affidavits and other certificates/ documents should be as per nativity/ domicile/ mool niwas certificate of a candidate. Alongside nativity certificate, all candidates should clearly mention their places of residence in the last five years at Para 1(b) (iv) of Appendix 'C'.
- 46. Candidates are requested to report to rally site with proper shave and hair cut so as to ensure proper identification and medical review.
- 47. Recruitment for Agniveer is purely based on merit list depending on available vacancies. Candidates do not have any right to claim recruitment in Army just for passing in recruitment process.
- 48. Candidates will be permitted entry into the rally site only on producing of Relationship Certificate, Education Certificate (Including 10th Class) and affidavit. Anyone found with fake documents will be handed over to Civil Police.
- 49. Affidavit for Non Involvement in Banned Political Organization and No Criminal Case. The candidates will submit an affidavit that he had or have not been a member of any banned/ political organization and have never been in custody/ jail and no criminal or judicial case is pending against me in any court of law in India/abroad. That I have not been ever convicted for any offence under the Law. Format attached at Appendix 'M'.
- 50. <u>Drug Abuse</u>. An indemnity bond to this effect that candidate participating in the recruitment rally has not used any means of **physical performance enhancing drugs during recruitment rally**, duly signed by the candidate will be submitted at the rally site prior to physical fitness test. Format attached at **Appendix 'N'**.
- 51. Assessment of Proficiency of Sports Persons for Recruitment Through Unit Headquarter Quota. Proficiency of Sports persons to be identify genuine talent will be assessed by regimental centre by a board of officers prior to putting them through the formal recruitment procedure.

(a) Level of participation, position to be obtained and bonus marks in CEE as per Para 53.

52. Following sports certificates will not be accepted.

- (a) Sports promotion participation certificate issued by various organization/entities under/various Ministers but not part of the recognized sports federations,
- (b) Zonal /Regional level certificate.
- (c) Registered societies not recognized.
- (d) Certificate issued by various Ministers at National/ State level other than the Sports Ministry recognized federations at National/ State level.
- (e) Talent hunt tournaments.
- (f) City marathon /cycling /other sports events sponsored by corporate or other such agencies.

Note :-

- (i) The above marks are fixed depending upon the eligibility of a candidate and no relation to his performance in Common Entrance Examination (CEE).
- (ii) Only one type of bonus marks (Max of the permissible) will be added to the total.
- (iii) Bonus marks will be accorded on qualifying in the written examination.
- (iv) Only one ward (daughter /son) of Service/Ex-servicemen/War Widow/Widow of Ex-servicemen can avail bonus marks in written examination.
- (v) Original certificates to be carried by all above categories at rally site.
- (vi) Sports certificate are valid for two years from the issued date as on first day of the recruitment rally for which the candidates is being screened.

54. Physical Measurement Test (PMT).

- (a) <u>Height</u>. For measurement of height fractions less than half centimeter shall NOT be taken into account. The same will be rounded off and recorded as under :-
 - (i) If fractions is upto 0.5 cms and below, round off to the lower side (Example: 169.5 cms to be recorded as 169.0 cms)
 - (ii) If fractions is 0.6 cms or above, round off to the upper side (Example: 169.6 cms to be recorded as 170.0 cms)
 - (iii) Weight. Weight will be taken on electronic scale.
 - (iv) <u>Chest</u>. The minimum measurement will be taken after the breath has been expelled from the chest and the maximum when the chest is fully expended. There must be a difference of at least five centimeters between minimum and maximum measurement.
- 55. <u>Medical Examination</u>. After completion of Physical Fitness Test (PFT), Physical Measurement Test (PMT) successful candidates will have to go through medical examination by the RMO. The RMO may refer the candidate to nearest Military Hospital for opinion of specialist, if required. Only medical 'FIT' candidates will be permitted to appear in Common Entrance Exam (CEE).
- 56. All candidates must clean their ears and remain medically fit before coming for recruitment.
- 57. Army authorities are not responsible for any **injury**, **death** or **loss** of academic session caused to any candidate during recruitment process. Candidates will participate at their own risk. Boarding/ lodging facility is not available within the Centre. Candidates will have to make their own arrangement during the conduct of entire recruitment rally and must take care of their documents/ belongings against theft.
- 58. No journey fare will be admissible to the candidates appearing in the recruitment rally.
- 59. Wards of Civil Employees who are paid out of Defence estimates, BSF, Airforece, Navy, GREF, Assam Rifles and MES are not permitted to attend the said recruitment rally.
- 60. All personnel taking part in Common Entrance Exam (CEE) will deposit oneself addressed registered envelope alongwith requisite postage stamps.

61. General Guidelines Against Malpractices.

- (a) Recruitment is a free service and candidates are cautioned against falling victims to unscrupulous agents/ middlemen/ touts. Candidates are warned not be pay any money to any such touts or make any kind of favorable arrangement with them as there is no way that they can influence recruiting process at this Centre.
- (b) Production of bogus/fake certificate and indulging in unfair means is a criminal offence and liable for punishment under law.

- (c) Candidates are also warned **not to** handover original documents /certificates to agents/ middlemen/ touts as they will only mislead. **Any involvement with touts will render your candidature null and void.**
- (d) Certificate with overwriting and tempering of seals or erasing /alteration of any type will not be accepted.
- (e) In case candidates come across any such touts/ Agents middlemen, the same must be immediately brought to the notice of the authorities this Centre.
- (f) No candidates will make an effort to contact any combatant and vice versa. No candidate is allowed to stay in the family quarters of staff posted in the Centre, even if he is a relative. Candidature of such cases will be cancelled.
- (g) Candidates will produce original documents for relaxation and bonus marks applicable for enrolment like Relationship certificate, NCC (A/B/C), ITI and sports at the time of Recruit Master Data Sheet feeding in software. After RMDS verification by the Presiding Officer no such documents will be accepted. Certificates with overwriting or tampering of seals or erasing or any type and provisional nature will not be accepted.
- (h) Candidates found not having the above mentioned certificates/ having only provisional certificate will be rejected from the rally site itself. Malpractices and attempted enrolment by producing fake certificate during the rally will call for disciplinary action against the defaulter by the civil police. Candidates who produce fake certificates will be handed over to the civil police.
- (j) Misrepresentation of facts/ concealment of any information if defected at any stage of recruitment process will lead to the cancellation of candidature of defaulter. Producing fake documents & giving false info will make you liable for terminating of your service despite any number of years service you may render.
- (k) The place for recruitment is out of bound for all ranks who are not involved in conduct of rally.
- (I) Army enrolment being a central government organization, all documents are required to be in **English or Hindi language** only. Candidates with certificate in state languages will produce a **translated true copy** of certificate without fail.
- 62. Selection is provisional till Enrolment Form/Verification Roll/ Willingness Certificate/ Joining Letters are issued and candidates are dispatched for training.
- 63. Candidates shall bring smart mobile phones for the rect rally. These will be permitted only for Adaptability test. All other time these mobile phones will be be kept in their bags in switched off condition.
- 64. Date of Common Entrance Exam will be intimated at rally site on the day of screening. Negative marking will be applicable in CEE.
- 65. At rally site, all candidates should report duly shaved (beard, chest, hair, auxiliary hair, public hair and with crew hair cut (except SIKH Candidates), for identification at various stages of rally process failing which candidate can be barred from participation in recruitment rally.
- 66. Candidates may have to present themselves at rally site for two to three times. Candidates should make arrangements for stay under their own arrangements.
- 67. Candidates are advised in their own interest to undergo medical exam before coming for selection especially with respect to flat food, poor vision, deformities and physical measurements. All are advised to ensure that their ears are free of wax by getting it cleaned by a doctor prior to the rally.
- 68. The complete process of recruiting at this Centre is absolutely transparent/ fair with different set of assessors/examiner for different stage of selection/screening and candidates must have faith in their abilities.

- 69. <u>COVID-19 Precautionary Measures</u>. All candidates will wear proper mask all the time. Additional precautionary measure may be employed depending upon prevailing situation at the time of rally.
- 70. All photocopy of documents submitted by the candidate will be self-attested with name, date and time.
- 71. Affidavits given at appendices to be produced by each candidate and **each page** should be **signed** by the **candidates**.
- 72. Contact Lenses. Use of contact lenses is not allowed.

IMPORTANT: It shall be the responsibility of each candidate to ensure that the relevant details as given in Relationship Certificate (Candidate name, Fathers name, Brother's name, Candidates date of Birth, Address) matches with corresponding details as given in Education Certificate/ Marks Sheet, Mool Niwas and Police Verification.
